## INCIDENTS

10/23/23 – Cheltenham Avenue/Pleasant Avenue – While conducting a traffic stop, Officers administered Standardized Field Sobriety Tests on a female driver. The driver did pass the tests and gave consent for the Officers to search the vehicle. While searching, Officers located 9.2 grams of marijuana and 10 ecstasy pills. The female driver was taken into custody and charged with drug possession related offenses.

10/24/23 – 1300 block Bruce Road – While at District Court, Officers were able to identify a male that had an active warrant from the Upper Dublin Township Police Department. The subject was taken into custody and released to Upper Dublin for his charges. This incident took place without problem or disruption of the Court.

10/24/23 – 400 block Haws Lane – Officers were dispatched to the area for two young males throwing rocks at the windows of an abandoned home. Officers were able to locate the subjects and contact their parents/guardians to discuss the matter. No charges were filed, and the males were sent on their way.

10/25/23 – 1000 S. Easton Road Cheltenham Township – Several Springfield Officers and Detectives responded with the Cheltenham Township Police Department for a Robbery In-Progress. As several Officers began arriving at the scene, it was determined that there was a 30-minute delay from when the incident occurred. All Springfield Officers/Detectives were released from the scene in a timely manner.

10/26/23 – Route 309/Paper Mill Road – Officers were dispatched for a report of a female walking on Route 309 wearing pajamas. Officers were able to locate the female and provide transport to the hospital for evaluation. Because she was located on Route 309, the incident was turned over to the Pennsylvania State Police – Belmont Barracks.

10/26/23 – 100 block Plymouth Avenue – Officers were initially dispatched to a large fight in progress involving 40-50 people. Upon arrival it was determined that the large gathering was people throwing toilet paper at homes as part of a tradition for the Springfield Township High School football team to prank their seniors by showing up at their homes and throwing toilet paper. Both the seniors and their parents took to the jokes and did not want any further police involvement.

10/26/23 – 1500 block Bethlehem Pike – Officers were dispatched to the area for a report of an occupied vehicle loitering in the back parking lot of businesses. Officers were able to contact the driver who was picking up a lawn mower that had just been serviced earlier that day. The driver was quickly sent on their way without issue.

10/27/23 – 500 block York Road, Jenkintown Borough – Springfield Officers responded to assist Jenkintown Borough Police at a fatal crash as part of the Eastern Montgomery County Crash Reconstruction Team. Springfield Officers remained on scene for several hours assisting Jenkintown Borough with the crash investigation as well as assisting the Coroner's Office with their Investigation. This incident is under the investigation of the Jenkintown Borough Police Department.
