- BoC Update Peter Wilson discussions on Anti-Asian Hate. 308 Haws Lane discussion. Developers will have May 28th open house at Flourtown Country Club to review and comment on the plan. Retirement of crossing guard. Talking to Sandy Run CC about improved storm water management on Berton Road. Passed resolution for extending filing of earned income taxes to May 17th. Agreed to reduce speed limit on Paper Mill road between Gulf and Church by 10 mph. Stop sign on Paper Mill and Edaan road. Traffic stuff for New Enfield to look at effect of the school on traffic. Passed resolution 1529 to support PA State house to allow local police departments to use radar (this is to encourage the state to say yes to encourage another tool in traffice enforcement). Obtained grant for police body cameras.
- PUC A "time of use" tariff coming into play in September. Different rates during the day. Need clarification on date it is effective.
- RF100 Melissa school district update. Craig Thorn is engaged and wants to be more engaged with the districts participation. Erdenheim and middle school are both geothermal. And it is working well. New Enfield school was looked at as part of construction. Just went through reeducation of staff on waste management. Also working with sustainability leads at the school and possibly La Salle. Also got data on the fuel use of the fleet. Just purchased new vehicles. Looking to replace those in ~ 10 yrs.
 - Stephen volunteered to help with getting messaging to various school related FB sites to get parents engaged.
- Transportation update read in from Deseriee who could not attend.
 - Drive electric week September
 - Good report from Solberry township on their use of hybrid police vehicles had for a few years. Love it, no issues.
- Police Hybrid is in, and is in fleet garage getting all decked out.
