Dear Mr. & Mrs. McDonnell,

This letter is sent to inform you that on Monday, April 26, 2021 the Zoning Hearing Board of Springfield Township approved the requested dimensional variance from Section 114-74.C of the Springfield Township Zoning Ordinance. This will allow for the requested encroachment into the rear yard setback area not to exceed 11 feet for the addition of a deck to the rear of your home. This approval will allow for the addition of the deck and must be constructed as per the plans submitted into the record for this application leaving a rear yard setback of 14 feet where 25 feet is otherwise required. This approval was conditioned as follows:

1. The rear of the property must be landscaped and the deck screened as per the testimony entered into the record.

The approval of this application was unanimous, and the Board found it significant that none of your neighbors opposed the application. The permit for the installation of this deck must be submitted within 12 months of the date of this letter.
