No Mow May Survey Results

Board of Commissioners Updates

- On 7/8/24, Ron Celentano presented the solar feasibility study to the Commissioners. It forecasts a 9.2 year payback period for putting solar panels on selected roofs of our municipal buildings.
- On 7/10/24, The Commissioners unanimously approved a motion for the Township to hire a structural engineering firm to perform structural analyses on the Police/Admin and Public Work roofs to ascertain that they will support solar panels.
- On 7/10/24, The Commissioners unanimously voted that Alex Waldman be appointed a full EAC member. Congrats and welcome, Alex!
- On 7/10/24, the Commissioners referred a request from Sierra Club that they sign a letter in support of Community Choice Aggregation to the EAC for further analysis.
- On 7/10/24, the Commissioners unanimously authorized the execution of an easement to protect from any future development 3.47 acres of Carson Valley property ("the Carson Meadow") as a stormwater detention basin.

Techo Trash

We filled up and shipped out a techno trash. It was our last one, so we are ordering another. Its been a steady pace on usage.

Bag ordinance

Ben went to the Dim Sum factory and made the manager aware of the bag ordinance. They were receptive to the information.

Reusable bags

Stephen will contact a few organizations to see if we can donate the bags to them.

Open Space Subcommittee

We have been recruiting for a participant from each of the following township commissions and advisory committees: Shade Tree Commission, Parks & Recreation Advisory Committee and the Planning Commission, as they are stakeholders in open space preservation in the township. So far, Ted Bell from the Shade Tree Committee has agreed to participate. We are still in the recruitment process for the other two. If you know of anyone from either of those groups that might be interested, please let me (Gail) know. We will schedule our next meeting once we have finalized the participants for this group.

Wissahickon Clean Water Partnership

The Partnership is in the final stages of drafting the shared Water Quality Improvement Plan. The goal is for the technical subcommittee to complete the analysis and review the draft in the next couple of months. Once the technical subcommittee has a finished draft, then the draft will be reviewed by the management committee at large. In the meantime, Wissahickon Trails will be meeting with each municipality (on behalf of the technical subcommittee) to review the project list associated with the plan to make sure it is still up to date. In addition, the group is working towards becoming a legal consortium, they currently have an RFP out for a lawyer to do the legal work associated with forming the consortium.
