1. **Resolution No. 1693 – Grove Avenue Right of Way** – accept the deed of dedication for a portion of the Grove Avenue ultimate right-of-way
2. **Indemnity Agreement – Foxlane Homes at Willow Grove** – authorize the execution of an agreement indemnifying Springfield Township for the installation of stormwater facilities to be constructed within the state right of way
3. **Resolution No. 1694 – Willow Grove Commons** – granting preliminary/final land development approval for the consolidation of four parcels in the 1000 block of Willow Grove Avenue and construction of a 4-story, mixed use building
4. **June Bill Listing** – review and approve the monthly bill listing and check reconciliation of the previous month
5. **Zoning Hearing Board** - announce the agenda of any special or regular meetings of the Zoning Hearing Board
6. **Recycling Report** – review and announce the monthly recycling activities
7. **Environmental Advisory Commission** – reappoint two existing members of the Environmental Advisory Commission to new, three-year terms of service
8. **Resolution No. 1695 – Community Choice Aggregation** – a resolution supporting legislation to enable all municipalities to pool the electricity demands of residents and small businesses to negotiate bulk electricity

9. **Public Safety Forum** – announce the June 18<sup>th</sup> Public Safety Forum featuring traffic laws, speed education and enforcement
10. **National Night Out** – announce the annual National Night Out event on Tuesday, August 4 at the Township’s municipal campus

12. **Community Canopy Project** – authorize the installation of 120 native riparian plantings (91 trees and 29 shrubs) at Mermaid Park
13. **Fuel Reimbursement Agreement – Police Chiefs Association of Montgomery County** – authorize the execution of an agreement to permit the refueling of a Major Incident Response Team vehicle
